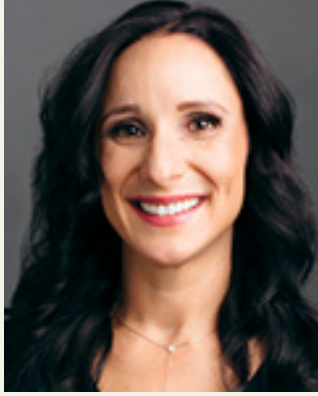

Dr. Zachary Houser, Director of the UNMC Pediatric Dental Residency Program shared, "The UNMC Pediatric Dental Residency is a dental home to thousands of children. 70-80% of our patients have Medicaid dental coverage, and 10-15% have private insurance. However, many of our patients cannot afford dental insurance. Our residency treated approximately 700 children without insurance from January to December 2023. The combination of low income and no insurance prevents families from seeking urgent dental care for their children.

Our program has gratefully applied ODDS funds to treat children with urgent dental needs and inability to pay. We try to stretch the fund to cover more children. For example, an ODDS gift of \$3000 provides urgent dental services for 10-15 children. The generosity of the ODDS membership makes it possible for parents to seek urgent dental care for their children with less financial fear."
